6. Hear update concerning website design and take any necessary action;
7. Discuss water conservation ideas and methods, and take any necessary action;
8. Hear update on surface water issues and take any necessary action;
9. Discuss trash service issues, including notice of recycling fee increase, and take any necessary action;
10. Consider amending Order Setting Water and Sewer Tap Fees and Service Rates regarding trash collection fee increase;
11. Consider approving Order Canceling Directors Election and Declaring Election of Unopposed Candidates;

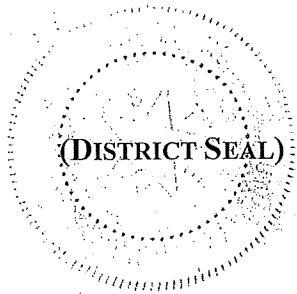
